

## CERTIFICATION EXAMS

AALAS has an Animal Technician Certification Program which serves two main purposes. It provides a mechanism for developing exceed these standards by awarding them certification at three different levels: Assistant Laboratory Animal Technician, Laboratory Animal Technician, and Laboratory Animal Technologist.

In order to qualify for AALAS certification, applicants must pass their exams (written and practical) and meet educational and experience requirements which are outlined in the AALAS publication 83-1, "The Animal Technician Certification Program".

- The minimum requirements to take the exams at each level are:
  (1) Assistant Laboratory Animal Technician must have completed grammar school, have 6 months of work experience in a laboratory animal facility and have education in animal science and/or relevant work experience totaling another 6 months.
- (2) <u>Laboratory Animal Technician</u> must have completed high school, have 2 years of work experience in a laboratory animal facility and have education in animal science and/or relevant work experience totaling another 2 years.
- (3) <u>Laboratory Animal Technologist</u> must have completed high school, have 2 years of work experience in a laboratory animal facility and have education in animal science and/or relevant work experience totaling another 3 years.

Provisional certificates for all three certification levels are given to those applicants who meet the educational requirements and pass the examination (practical and written), but who do not yet meet the experience requirements. A provisional certificate is valid for 3 years.

A candidate may apply for provisional certification once the education requirement is met and his or her instructor makes the recommendation.

Once the experience requirements have been met, the candidate may apply for full certification.

## AALAS Technician Continuing Education Registry

AALAS's Animal Technician Certification Program was an important step toward improving the overall care of animals used in research. However, the field of laboratory animal science is changing rapidly, with new knowledge, techniques and concepts being introduced almost daily. So it is essential that animal care workers periodically update their skills and knowledge to remain on the cutting edge of their profession. The AALAS Continuing Education Registry, authorized by the Board of Trustees in 1989, was designed to encourage such professional growth.

The AALAS continuing Education Registry is a voluntary program for documenting continuing education for all certified Assistant Laboratory Animal Technicians, Laboratory Animal Technicians, and Laboratory Animal Technologists. The term "technician," when used in this program, refers to persons certified at all three levels.

The purpose of the AALAS Continuing Education Registry is two fold: 1) to record the technicians continuing education, and 2) to encourage a standard for the minimum level of continuing education

efforts to present and prospective employers. The program also provides managers of laboratory animal facilities with a ready reference of those technicians who are making an effort to keep their knowledge and skills up-to-date.

## THE ACT - What Animals Should Be Covered? By Dr. Elizabeth Evans

There has long been controversy about which species should be covered by the Animal Welfare Act. The definition of animal in the Act includes any dog, cat, nonhuman primate, guinea pig, hamster, rabbit, or any other warm blooded animal which is dead or alive. Animals covered must be used or intended for use for research, testing, experimentation, or exhibition purposes, or as a pet. All dogs including those used in hunting, security, or breeding are covered by this law.

However, some species of animals are specifically excluded in various ways. Previously, birds, rats and mice have been excluded. Birds are still excluded but this recent amendment goes a bit further regarding rats and mice. Rats of the genus <u>Rattus</u> and mice of the genus <u>Mus</u> are specifically listed as the species of rodents that are bred for research. This means that rats or mice in other genera, such as the kangaroo rat are indeed covered by this Act.

Also excluded from the Act are horses and other farm animals that are used for food or fiber, for improving animal nutrition, breeding, management, or production efficiency or improving the quality of food or fiber. This means that horses, cattle, sheep, goats, pigs, and poultry can be used for research involving feed efficiency, farm management, breeding techniques, and related studies without coverage by regulations in the Animal Welfare Act. If these species are used for biomedical research which is to be extrapolated to human beings, they are then provided coverage under the Act. This would include the use of sheep and goats for antibody production, pigs for surgical techniques including transplants, or testing of pharmaceuticals for possible human use. When these species are intended for such biomedical uses, their care and use must follow the regulations specified in the Animal Welfare Act, including caging, light, temperature , humidity, transport, etc.

Institutions that receive money from Public Health Service (including NIH, NCI, etc.) must also follow the Public Health Service Policy. This policy is different from the Animal Welfare Act in that it does not exclude rats and mice regardless of their genus level of classification.

Many people in the lab animal profession believe that it is only a matter of time before rats and mice of all genera are included in federal legislation. If this does not happen, hundreds of small laboratories using only mice and rats will then be covered by the Animal Welfare Act and need to be inspected by REAC (division of USDA), creating an increased workload and budget demand for the department.
