

Cindy mentioned that a sign-up sheet for volunteers for the 1996 District Eight Convention Committees was being passed around and she hoped that everyone would become more involved and sign up. This list of committees and a contact number will be included in the newsletter.

Cindy mentioned that the Board has proposed amendments to the Arizona AALAS constitution and by-laws. The proposed changes are: 1. Change Vice President to President Elect - this would be a 3 year commitment, 1 year as vice president, a year as president and then a year as past president - to add to the continuity and experience of the board; 2. Change the Technician Branch Representative from an appointed position to an elected position to allow more member involvement in the decision; and 3. Change the Board Member positions so that we have regional representation - A northern member and a southern member to ensure wider representation from the state as a whole. The proposed changes and ballot are included in this newsletter.

Secretary/Treasurer Grace Aranda mentioned that the branch plans on holding

another wet lab the last week in March or early April. This lab would be on the care and handling of rodents and rabbits. Further information will be available later on the exact date and cost for this lab. An announcement will be in the newsletter.

Jane Criswell, who is in charge of getting speakers for this year, requested that any ideas be called in to her.

The suggestion has been made to have a Spring Hayride and Cookout instead of the usual May picnic. Member Susan Sanders has offered to let the Branch host something at her new ranch.

Grace mentioned that the 1995 District Eight Meeting will be in Riverside, California in May. A request has been made by Sharon Jahn, ATCB Chair, that anyone interested in the Item Writing Workshop for the Certification Exams give her a call by February 14.

Susan asked how many certification exams have been requested and taken since the new system was instituted. Response from Ron and Casey were that fewer tests were being requested and taken due in part to the cost and difficulty of traveling to a testing station. It was mentioned that University Animal Care may end up developing their own system due to these prohibitory factors. Ron stated he would bring up the issue to National.

The Riverside Holiday Inn not only offers spacious rooms at a reasonable price along with easy access to the Convention Center, but will provide complimentary shuttle service to and from Ontario International Airport with advanced reservations.

Although the meeting officially begins on Monday, there will be plenty to do on Sunday, May 7th. Sharon Jahn will facilitate the Item Writing Workshop from 9:00 a.m. until noon; Pharmacal will sponsor a picnic that afternoon; and Palms to Pine Branch will kick off the night-before-the-meeting with a Casino Night Party! His talk is titled, "From Bones and Stones to Balloons and Toons: The Intersection of Science and Art." Dr Sumida bases his talk on his work consulting with the Walt Disney studios on animation of animals.

Tuesday's slate is not quite so full - although lunch will again be provided, the evening is left free for you to explore any of the fine restaurants and microbreweries near the convention center. Topics scheduled for this day include operant conditioning in primates, the influence of environmental factors on behavior, and animal allergies. At 5:00 p.m. we will have a drawing for prizes for any meeting participant who has visited all of the vendors and returned the completed form found in the registration packet.

We've saved the best for Wednesday! The morning will begin with a mock IACUC discussing protocols, issues and controversies often faced by such committees. Controversy will follow controversy as the meeting ends with a debate between an animal rights activist and a research scientist. Since the meeting officially ends at noon, lunch will not be provided. For those who can stay the rest of the day, Palms to Pine Branch has chartered a bus to take us to a working winery in nearby Temecula for a tour and wine tasting. The bus will depart the Riverside Holiday Inn at 1:00 p.m. and return by 5:00 p.m.

AWARD NOMINATIONS DUE

Nominations are now being accepted for this year's Technician/Member of the Year Awards. Only members in good standing may nominate and be nominated. These awards will be presented at the Annual Dinner. Nominees must meet the following criteria:

- ✓ Must be a member in good standing of the Arizona Branch of AALAS
- ✓ Must have a year's worth of animal/animal related experience

Member of the Year

Nominee has exhibited devotion in personal time to assist in organization of programs, workshops, and other functions provided by the branch. Nominee encourages active participation within the branch, works diligently to meet deadlines, regardless of other daily obligations. Nominee volunteers to assist fellow members and provide support when needed. Education through meeting attendance along with active membership in the branch are viewed important for continued growth in the field of laboratory animal science. Exceptional accomplishments may include measures to encourage animal welfare in research, active participation in the local and national organizations for continued education, any paper presentation, articles or awards received to recognize exceptional contributions to the field of laboratory animal science along with active participation in community education and support.

Technician of the Year

Nominee demonstrates a positive attitude and a dedicated approach to the betterment of animal care through technical performance and education at their facility. Individual accomplishments may include participation in the AALAS certification process, assistance in facility training for fellow technicians, and the addition of personal certificates/diplomas earned in animals care related education. Any facility project initiated by a nominee to alleviate animal distress, enhance facility management, decrease animal numbers, or encourage skills in animal nursing and should be recognized. Exceptional accomplishments may include measures to encourage animal welfare in research, active participation in the local and national organizations for continued education, any paper presentation, articles or awards received to recognize exceptional contributions to the field of laboratory animal science along with active participation in community education and support. Must hold supervisor position or below.

Nomination forms are included in this newsletter and must be returned by April 28, 1995. Arizona Branch nominees will also be forwarded to the National office to be included in the National Awards Program.

CERTIFICATION EXAMS - Answers to Questions about the Certification Program

How do I get a certification application or information about the AALAS Animal Technician Certification Program?

Call Grace at (602)621-1330 for an application pamphlet.

How do I apply for an examination?

Carefully read the applicant information package. If you meet the criterion complete the application and return it in the self-addressed envelope to the Professional Examination Service for processing. If your application is complete and you meet the criterion for examination, you will be sent a post card notifying you that you are eligible to take the exam. If your application is returned because you do not meet the requirements or because the application is not complete, you will be required to send an additional \$25.00 fee when you resubmit your application.

When are examinations offered?

The examinations will be administered via computers at over 250 testing sites around the country. When you receive your post card advising you that you are eligible to take the examination, you will call the testing site and schedule the examination. Exams may be scheduled at the applicants convenience, Monday through Friday, from 9 a.m. to 4 p.m.

How and when will I receive the results of my exam?

Because the examination questions have been rewritten, they must be re-validated before results can be released. One hundred examinations are required at a given level to validate the questions at this level. After the initial 100 examination have been administered at a level, examinees will receive their results immediately at the testing center when they complete the examination. If you pass, a letter of acknowledgement and an individually numbered certificate will be forwarded to you at a later date.

What are the requirements for AALAS certification? The requirements are as follows:

Assistant Laboratory Animal Technician (ALAT)

- Graduate of a two-year degree program, (AA, AAS, or AS) in Veterinary Technology from an AVMA accredited program; or
- Graduate of a four-year BA/BS program in Veterinary Technology from an AVMA accredited program; or
- Licensed DVM
- High school diploma or GED and upon completion or one year of animal care experience in an approved facility, defined as a facility with either a USDA registration, AAALAC accreditation or PHS assurance number

Laboratory Animal Technician (LAT)

- ALAT certification and one year of additional experience in an approved facility, defined as a facility with either a USDA registration, AAALAC accreditation or PHS assurance number; or
- Graduate of a two-year program (AA,AAS,AS) in Veterinary Technology from an accredited program and two-years of additional animal care related experience in an approved facility, defined as a facility with either a USDA registration, AAALAC accreditation or PHS assurance number; or
- Graduate of a four-year BA/BS program in Veterinary Technology from an AVMA accredited program; or

- Licensed DVM; or
- High school diploma or GED and upon completion of three years of animal care experience in an approved facility, defined as a facility with either a USDA registration, AAALAC accreditation or PHS assurance

Laboratory Animal Technologist (LATG)

- LAT certification and one year of additional experience in an approved facility, defined as a facility with either a USDA registration, AAALAC accreditation or PHS assurance number; or
- Graduate of a two-year program (AA,AAS,AS) in Veterinary Technology from an accredited program and two-years of additional animal care related experience in an approved facility, defined as a facility with either a USDA registration, AAALAC accreditation or PHS assurance number; or
- Graduate of a four-year BA/BS program in Veterinary Technology from an AVMA accredited program and three years additional experience in an approved facility, defined as a facility with either a USDA registration, AAALAC accreditation or PHS assurance number; or
- Licensed DVM; or
- High school diploma or GED and upon completion of three years of animal care experience in an approved facility, defined as a facility with either a USDA registration, AAALAC accreditation or PHS assurance

How does the Professional Examination Service verify my employment?

The applicant must provide proof of the dates and duties involved for each employer listed. Verification by employers must be notarized on forms provided with the application. In addition, approximately 10% of the applications will be carefully screened by AALAS to verify the applicant's employment information. Applicants who misrepresent their credentials may be permanently barred from the certification program.

How much does it cost to take the certification exam?

Fees for 1995 will be as follows:

Please note: Copies of membership cards must be sent with the application form, and membership fees may no longer be sent with the application. Therefore, to qualify for the member rate, you must obtain your AALAS membership and receive your membership card before sending your application form. Proposed Changes to the Constitution for the Arizona Branch of the American Association for Laboratory Animal Science

Article V, Section 1 - Officers

Original:

There shall be a President, Vice President, Immediate Past President, and Secretary/Treasurer.

Proposed Change No. 1

There shall be a President, President-Elect, Immediate Past President, and Secretary/Treasurer.

Article VI - Board of Directors

Original:

Section 1.

The Board of Directors, composed of the Officers, two additional elected members, and an appointed Technician Branch representative shall be the legislative and administrative body of the Branch. It shall have the charge of the property and financial affairs of the Branch and perform all the duties as described in the Bylaws.

Proposed Change No. 2:

Section 1 - Composition

The Board of Directors, composed of the Officers, an elected Technician Branch Representative and two additional elected members shall be the legislative and administrative body of the Branch. One of the two additional elected members shall be elected by the association's membership in the northern half of the State of Arizona, and the other member shall be elected by the southern members to ensure equal representation.

Section 2 - Responsibility

The Board of Directors shall have the charge of the property and financial affairs of the Branch and perform all the duties as described in the Bylaws.





Certification News

A checklist is provided on the back of the Candidate Application Handbook for you to verify that you have all the information required by PES to process your application. An incomplete application will only delay your sitting for the exam in a timely manner.

PES processes applications weekly (Wednesdays), with approval letters mailed on Thursday of each week.

Annual Report: PES began administering the new technician certification examinations in March of 1994. The number of technicians applying for and taking exams dropped off dramatically from 3,132 in 1992 to 292 in 1994. With fee increases, change in eligibility criteria, and the move to computerized testing, technicians have been reluctant to apply for the exam.

The percentages of candidates passing the exams from March 1994 to present have remained fairly consistent with past years: ALAT (75%), LAT (76%), and LATG (35%). The LATG level has a lower percentage of candidates passing, however, as only 66 candidates have tested at the LATG level thus far. To date,

previous years (note: AALAS tested 734 candidates at the LATG level in 1993).

Many candidates who have been applying with the minimum qualifications have not had enough experience in the field and have had a difficult time with the examinations.
