GENERAL MEETING SUMMARY

The meeting was held at the College of Medicine in Room 1119BC on February 14, 1994. President Tim Martin called the meeting to order at 12:10 p.m. Tim announced the members of the board.

Grace went over our financial accounts. We have about \$5000.00 in various accounts.

This year's Fall Symposium will be held in Flagstaff, September 30 and October 1, at the Little America Hotel. Room rates are \$58.00 dollars single occupancy, \$68.00 double occupancy, and \$10.00 for an additional person. A call for papers and registration information is included in the newsletter.

Cheryl discussed the major changes in the AALAS National Testing Application. AALAS has decided to use a testing service, PES. The test can be taken any time in Phoenix. Results will be given immediately after you take the test

once the first 100 pilot tests have been completed. The costs of the test have been increased to cover the cost of the new testing service and the initial set-up costs.

Fees must be sent with your application. If PES finds your application incomplete it will be returned. Resubmitted applications will require an additional processing fee of \$20.00. No fees will be refunded after an application has been processed for AALAS by PES.

Tim wants to expand our local branch of AALAS by getting more people interested in it. Since AALAS was formed to be an educational organization, he asked for volunteers to be on an Education and Training Committee. Jane Criswell, Beth Skovan, Cheryl Johnson, Karen Blohm and Tim Martin volunteered. The committee will examine the feasibility of offering wet labs and improving attendance at the general meetings.

National Membership dues through University Animal Care had to be given to Mark Barton by February 28, or forwarded to National AALAS, for your name to be included in the Directory by March 31st.

- ✓ Must be a member in good standing of the Arizona Branch of AALAS
- ✓ Must have a year's worth of animal/animal related experience

Member of the Year

Nominee has exhibited devotion in personal time to assist in organization of programs, workshops, and other functions provided by the branch. Nominee encourages active participation within the branch, works diligently to meet deadlines, regardless of other daily obligations. Nominee volunteers to assist fellow members and provide support when needed. Education through meeting attendance along with active membership in the branch are viewed important for continued growth in the field of laboratory animal science. Exceptional accomplishments may include measures to encourage animal welfare in research, active participation in the local and national organizations for continued education, any paper presentation, articles or awards received to recognize exceptional contributions to the field of laboratory animal science along with active participation in community education and support.

Technician of the Year

Nominee demonstrates a positive attitude and a dedicated approach to the betterment of animal care through technical performance and education at their facility. Individual accomplishments may include participation in the AALAS certification process, assistance in facility training for fellow technicians, and the addition of personal certificates/diplomas earned in animals care related education. Any facility project initiated by a nominee to alleviate animal distress, enhance facility management, decrease animal numbers, or encourage skills in animal nursing and should

be recognized. Exceptional accomplishments may include measures to encourage animal welfare in research, active participation in the local and national organizations for continued education, any paper presentation, articles or awards received to recognize exceptional contributions to the field of laboratory animal science along with active participation in community education and support. Must hold supervisor position or below.

Nomination forms are included in this newsletter and must be returned by April 25, 1994. Arizona Branch nominees will also be forwarded to the National office to be included in the National Awards Program.

CERTIFICATION EXAMS - Answers to Questions about the Certification Program

How do I get a certification application or information about the AALAS Animal Technician Certification Program?

Contact the AALAS office, 70 Timber Creek Drive, Cordova, TN 38018; (901) 754-8620. The office will send you an application request card to send to the Professional Examination Service to request a candidate information package. Please do not contact the Professional Examination Service directly as this will only delay your request.

How do I apply for an examination?

Carefully read the applicant information package. If you meet the criterion complete the application and return it in the self-addressed envelope to the Professional Examination Service for processing. If your application is complete and you meet the criterion for examination, you will be sent a post card notifying you that you are eligible to take the exam. If your application is returned because you do not meet the requirements or because the application is not complete, you will be required to send an additional \$25.00 fee when you resubmit your application.

When are examinations offered?

The examinations will be administered via computers at over 250 testing sites around the country. When you receive your post card advising you that you are eligible to take the examination, you will call the testing site and schedule the examination. Exams may be scheduled at the applicants convenience, Monday through Friday, from 9 a.m. to 4 p.m.

How and when will I receive the results of my exam?

Because the examination questions have been rewritten, they must be re-validated before results can be released. One hundred examinations are required at a given level to validate the questions at this level. After the initial 100 examination have been administered at a level, examinees will receive their results immediately at the testing center when they complete the examination. If you pass, a letter of acknowledgement and an individually numbered certificate will be forwarded to you at a later date.

What are the requirements for AALAS certification? The requirements are as follows:

Assistant Laboratory Animal Technician (ALAT)

- Graduate of a two-year degree program, (AA, AAS, or AS) in Veterinary Technology from an AVMA accredited program; or
- Graduate of a four-year BA/BS program in Veterinary Technology from an AVMA accredited program; or
- Licensed DVM
- High school diploma or GED and upon completion or one year of animal care experience in an approved facility, defined as a facility with either a USDA registration, AAALAC accreditation or PHS assurance number

Laboratory Animal Technician (LAT)

- ALAT certification and one year of additional experience in an approved facility, defined as a facility with either a USDA registration, AAALAC accreditation or PHS assurance number; or
- Graduate of a two-year program (AA,AAS,AS) in Veterinary Technology from an accredited program and two-years of additional animal care related experience in an approved facility, defined as a facility with either a USDA registration, AAALAC accreditation or PHS assurance number; or
- Graduate of a four-year BA/BS program in Veterinary Technology from an AVMA accredited program; or
- Licensed DVM; or
- High school diploma or GED and upon completion of three years of animal care experience in an approved facility, defined as a facility with either a USDA registration, AAALAC accreditation or PHS assurance

Laboratory Animal Technologist (LATG)

- LAT certification and one year of additional experience in an approved facility, defined as a facility with either a USDA registration, AAALAC accreditation or PHS assurance number; or
- Graduate of a two-year program (AA,AAS,AS) in Veterinary Technology from an accredited program and two-years of additional animal care related experience in an approved facility, defined as a facility with either a USDA registration, AAALAC accreditation or PHS assurance number; or
- Graduate of a four-year BA/BS program in Veterinary Technology from an AVMA accredited program and three years additional experience in an approved facility, defined as a facility with either a USDA registration, AAALAC accreditation or PHS assurance number; or
- Licensed DVM; or
- High school diploma or GED and upon completion of three years of animal care experience in an approved facility, defined as a facility with either a USDA registration, AAALAC accreditation or PHS assurance

How does the Professional Examination Service verify my employment?

The applicant must provide proof of the dates and duties involved for each employer listed. Verification by employers must be notarized on forms provided with the application. In addition,

approximately 10% of the applications will be carefully screened by AALAS to verify the applicant's employment information. Applicants who misrepresent their credentials may be permanently barred from the certification program.

How much does it cost to take the certification exam?

Fees for 1994 will be as follows:

Recipient of AAALAC's Bennett J. Cohen Award

John B. Mulder, D.V.M., was the second recipient the American Association for Accreditation of Laboratory Animal Care (AAALAC) most prestigious award, the Bennett J. Cohen Award.

AAALAC named this award in honor of Bennett J. Cohen, D.V.M., Ph.D., a unique individual, pioneer and visionary in the field of laboratory animal science. He was the founder of several well-known laboratory animal science organizations including AAALAC, AALAS and the American College of Laboratory Animal Medicine (ACLAM). Dr. Cohen was an ardent friend of the animal research and life science community and a steadfast supporter of AAALAC and the accreditation process. His numerous accomplishments gained him worldwide recognition, especially in the field of gerontology. Inspired by his ideals and dedication to biomedical research, the scientific community came to recognize the importance of developing standards for animal care and use by organizing a voluntary accreditation program. The incorporation of AAALAC in 1965 represented more than 15 years of Dr. Cohen's efforts toward improving laboratory animal care and use.

The Bennett J. Cohen Award recognizes highly unique individuals who have provided insight, distinguished leadership and dedication to the discipline of laboratory animal science and have demonstrated a commitment to advancing the quality of laboratory animal care in research, teaching and testing. The award was created to honor prominent individuals who, like Dr. Cohen, strive to meet their goals with a high degree of responsibility, integrity and compassion.

Dr. Mulder was a member of the AAALAC Council on Accreditation for 8 years and was Chairman of the Council during the last 3 years of this appointment. He was instrumental in facilitating AAALAC accreditation of the University of Kansas and the campus-wide University of Arizona animal care and use programs. He has 25 years of experience managing animal care and use programs, overseeing planning and construction of animal facilities and providing professional judgement in accordance with the Guide for the Care and Use of Laboratory Animals and the Animal Welfare Act.

Dr. Mulder is a Diplomate of the ACLAM and has served as President of the AALAS and the American Society of Laboratory Animal Practitioners. He has published over 100 scientific, historical, educational or motivational articles. Frequently, he provides consulting services for universities and corporations.

PROPOSED AMENDMENTS TO "THE ARIZONA BRANCH AALAS CONSTITUTION"

ARTICLE VI - Board Of Directors - Section 1

The Board of Directors, composed of the Officers and two additional elected members, shall be the legislative and administrative body of the Branch. It shall have the charge of the property and financial affairs of the Branch and perform all the duties as described in the Bylaws.

Proposed addition:

The Board of Directors, composed of the Officers, two additional elected members, and an appointed Technician Branch Representative shall be the legislative and administrative body of the Branch. It shall have the charge of the property and financial affairs of the Branch and perform all the duties as described in the Bylaws.

PROPOSED AMENDMENTS TO "THE ARIZONA BRANCH AALAS BY-LAWS"

ARTICLE III - Officers, Election Of - Sections 1 & 4

All officers of the Branch shall be elected for a period of one year. The officers must be members of the branch in good standing.

Proposed addition:

All officers of the Branch shall be elected for a period of one year. The officers must be members of the branch in good standing. The President must be a member of the national organization.

4a:Each year one member shall be elected to serve on the Board of Directors for a term of two years.

Proposed addition:

4b:Every two years the President shall appoint a member in good standing to serve as the Technician Branch Representative (TBR) for a term of two years. The TBR must be a member of the national organization.

ARTICLE IV - Officers, Duties Of - Section 5

Proposed addition:

Technician Branch Representative The Technician Branch Representative shall serve as a liaison between the branch members and the Board of Directors and also between the members and the national American Association for Laboratory Animal Science. He/she shall assist branch members in obtaining information/applications for AALAS certification testing.

ARTICLE VI - Committees - Responsibilities - Section 2a

The Membership Committee shall carry out all activities pertaining to membership as directed by the President, such as soliciting membership, notifying delinquent dues members, and preparing reports of membership for the Board of Directors. The Nominations Committee shall select at least two members in good standing as candidates for each elective office at least thirty days prior to September 1 of each year and submit these names to the President, who in turn shall submit the names to the Board of Directors.

Proposed change:

The Membership Committee shall carry out all activities pertaining to membership as directed by the President, such as soliciting membership, notifying delinquent dues members, and preparing reports of membership for the Board of Directors. The Nominations Committee shall elicit nominations from the branch members for candidates for each elective office at least thirty days prior to October 1 of each year. This committee shall insure all nominees are members in good standing, prepare a ballot, and tally all votes.
